We also offer an alternative session from 8:00-3:00pm with no food provided. Children booked for this session must be collected at 12:00pm and returned at 1:00pm, having had some lunch at home. This session does not incur any cost to parents and utilises 6 hours of government funding. We are not able to accept packed lunches during this session. There will be a late fee charge of £5 per 5 minutes from 12:00pm, as this hour is not covered by funding.

### AFTER SCHOOL CLUB FEES

Our after-school care clubs are very popular, and bookings are made via the Parent Portal. The sessions are charged separately to the termly fees. Our Stay and Play Club includes a drink and a snack, and our Picnic Club includes a hot or cold supper for the children. Bookings can be made or cancelled up until 11.00am on the day. Bookings not cancelled will still be charged.

### LITTLE EDS HOLIDAY CLUB

Little Ed's holiday club offers additional care for current Nursery and Reception children during the school holidays. A hot meal and snacks are provided each day. Bookings can be made via the Parent Portal and charged at a daily rate of £50.00.



# EARLY YEARS

## Free Entitlement



### EYFE FUNDING FOR 3 & 4 YEAR OLDS

All children attending our nursery are entitled to receive the universal 15 hours Government EYFE funding from the term after their 3rd Birthday until the term of their 5th Birthday. From September 2025, we will also offer the extended 30 hours entitlement for those parents that are eligible for 'Working Parent Entitlement'. This can be claimed as follows:

6 hours on a full day session

3 hours on a full day session

We do not offer the funding on a half-day session.

Parents will be asked to complete a declaration form for the local authority at the beginning of each term, in order for us to claim the funding for their child(ren). Parents eligible to receive the extended 30 hours will be asked to provide the code supplied to them by HMRC. Please see below on how to apply.

### WORKING PARENT ENTITLEMENT FUNDING FOR 2 YEAR OLDS

From September 2025 the government are offering 30 hours of 'Working Parent Entitlement' funding. This is available to all eligible parents of 2 year olds from the term after their 2nd birthday, providing that:

- They meet the eligibility criteria set by the government
- Their child attends a setting that will offer the funding for 2 year olds.

Parents will be required to provide us with their eligibility code in order for us to be able to apply the funding. Parents are required to confirm their eligibility via their HMRC childcare account every 3 months and provide us with this confirmation.

The funding can be claimed as follows:

6 hours on a full day session

3 hours on a full day session

We do not offer the funding on a half-day session.

Nursery fees are payable for the hours and services that are not covered by either funding option. Parents may divide their 15 or 30 hours between Little Ed's and another childcare provider, providing your claim does not exceed 30 hours per week with us. Please note that although funding is payable for up to 38 weeks of the year, at Little Ed's your claim will be for 33 weeks only, and the current rules do not allow you to claim the remaining weeks elsewhere. Funding can not be applied to holiday club sessions.

### CHANGING SESSIONS

**Reducing the number of sessions attended:** Please note that we require four weeks' notice in writing if you wish to reduce the number of sessions your child attends nursery. Credit for sessions already invoiced for will only be issued on receipt of the correct notice. Please also note that we require a terms notice in writing for the termination of a nursery place. If your child leaves nursery during the term, please be aware that you may lose the funding entitlement for the remainder of that term.

**Increasing the number of sessions attended:** Please speak to the Head of EYFS if you wish to increase the number of sessions your child attends during a term.
