After School Club Fees

Our after school clubs are very popular and booking is made via the parent portal. We offer optional pick up times to suit all of our families. A drink and snack is offered during each club and our Supper Club offers a combination of hot and cold meals served during the week.

Little Ed's Holiday Club

Little Ed's Holiday Club offers 13 weeks of care during the school holidays to current Nursery pupils. This is bookable via the Parent Portal and is charged as an extra at a daily rate of £45.00.

Early Years Free Entitlement

EYFE funding

Children whose birth dates fall within the eligibility dates shown below are entitled to claim up to 15 hours of Early Years Free Entitlement (EYFE) funding per week. The EYFE can be claimed as follows:

- $2\frac{1}{2}$ hours in any afternoon session
- 6 hours or 3 hours in any Full Day
- 15 hours in a Full Week

EYFE cannot be claimed in the morning session.

Nursery fees are payable for the hours and services that are not covered by the EYFE funding. You may divide your claim between Little Ed's and another nursery, providing your combined claim does not exceed 15 hours per week. Please note that although EYFE funding is payable for up to 38 weeks per year, at Little Ed's your claim will be for 33 weeks only – and the current rules do not permit you to claim the remaining weeks elsewhere.

EYFE eligibility dates

All children in independent schools are eligible to receive funding from the term after they turn 3 years old up until the term they turn 5 years old.

Parents will be asked to complete a declaration form for the local authority in order to claim the funding for their child (ren) and these will be issued at the beginning of each term.

In subsequent terms, parents are required to sign a Declaration of Attendance form at the School, confirming the number of hours claimed each week.

EYFE claimants, please note

Reducing the number of sessions attended: Please note that after the term has started and invoices have been issued, we require four weeks' notice in writing if you wish to reduce the number of sessions your child attends: credit for sessions already paid for will only be issued on receipt of the required notice. If you have claimed EYFE funding and you reduce your funded sessions during the term, of if your child leaves St. Edmund's during the term and you claim funding at another nursery, please be aware that you may consequently lose your entitlement to claim EYFE at St. Edmund's, in which case you would be invoiced for the element of your fees that was covered by EYFE.

Increasing the number of sessions attended: Please speak to the Nursery Manager if you wish to increase the number of sessions your child attends. If your initial EYFE claim was for less than your full entitlement and during the term you wish to increase the number of sessions that your child attends, you may be eligible to claim additional hours up to the maximum of 15 hours per week, subject to Surrey County Council's permitted dates for accepting amendments during that term.
